Tax Payer:

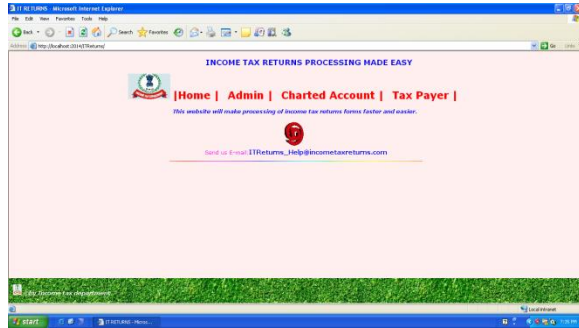
